

## Fonseca Bin 27 Cocktail Contest Official Rules

- 1. NO PURCHASE NECESSARY.** The Fonseca Bin 27 “Win a Billboard” Promotion (the “Contest”) begins on September 1, 2017 at 10:00 AM ET and ends on April 30, 2018 at 5:00 PM ET (the “Contest Period”). The Sponsor of this Contest is Kobrand Corporation, 1 Manhattanville Rd., Purchase, NY 10577 (“Sponsor”). Sponsor is the official time keeper for this Contest.
- 2. ELIGIBILITY:** The Contest is open to legal residents of the 50 United States and D.C., ages 21 or older. California retailers, wholesalers, and importers of alcoholic beverages (including their family members, agents, and employees), as well as certain other California licensees of alcoholic beverages (including their family members, agents, and employees) are not eligible to enter or win this Contest. HOW TO ENTER:** You must enter the Contest on the “Time for 27” page at [www.bin27port.com](http://www.bin27port.com) or visit Facebook at [www.facebook.com/FonsecaBIN27](http://www.facebook.com/FonsecaBIN27) (“Fonseca Bin 27 Page”) and click on the enter contest link. You must be 21 years of age or older and have a Facebook account in order to enter. If you do not already have a Facebook account, follow the directions when prompted to sign up without charge. Then, follow the directions to complete and enter. To enter, complete the entry form, including recipe name, ingredients and directions, suggested moment to enjoy the cocktail, agree to the terms and hit the submit button. Photo or video upload is suggested. There is no limit to the number of entries per person. Incomplete, inaccessible, corrupted, unreadable or unintelligible submissions will be disqualified. Any attempted form of entry other than as expressly specified in these rules (including but not limited to automated, copies, third-party or mechanically reproduced entries) is strictly prohibited and will result in disqualification. By participating in this Contest, you fully and unconditionally agree to all of the terms and conditions of the Privacy Policy of Sponsor located at [www.kobrandwineandspirits.com/privacy](http://www.kobrandwineandspirits.com/privacy), and you further fully and unconditionally agree to be bound by these Official Rules and all decisions of the Sponsor shall be final and binding on all aspects of the Contest.
- 4. WINNER SELECTION:** Cocktail must be an original recipe AND must contain Fonseca Bin 27 as an ingredient. Creativity “points” will be awarded for the cocktail and for the suggested moment to enjoy. One (1) winner will be selected from all eligible entries received. Only entries received during the Contest Period will be eligible for the judging. The judging for the Prize will be conducted by Sponsor at its principal place of business. As a condition of being awarded the

Prize, the potential winner must comply with these Official Rules as published (including all eligibility requirements), be confirmed as the official winner and execute and deliver appropriate information via email. The potential Prize winner will be notified of winning via email within twenty four (24) hours after the judging. The potential winner will be required to sign and return, within five (5) days of the delivery thereof to the potential winner, an affidavit of eligibility, and a liability/publicity release (except where prohibited) in order to claim his/her prize if applicable. If the potential Prize winner does not respond within 5 business days after notification, the potential winner will be disqualified and an alternate potential winner will be selected from among the remaining Eligible Entries, if any.

5. **PRIZES/ODDS:** Prize consists of a Billboard or other Out Of Home Placement(s) in winner's home town to announce the winning entry. The advertisement will be placed for one four-week cycle featuring winner's name, image and winning cocktail. Estimated prize value is \$4,900. Any prize details not specified above will be determined by Sponsor, in its sole discretion. No more than the stated number of prizes will be awarded. Odds of winning depend on the number of eligible entries received. Prize may not be substituted or transferred, except, if prize becomes unavailable, Sponsor reserves the right to substitute one for equal or greater value. No cash alternative, except in Sponsor's sole discretion. You are not a winner until validated and you receive official notification from Sponsor and you have properly responded as set forth above.
6. **GENERAL CONDITIONS/INDEMNIFICATION:** Sponsor's failure to enforce any provision of these Official Rules in a given circumstance shall not constitute the waiver of such provision. By participating in this Contest and/or by accepting any prize you may be awarded, you agree that the Sponsor, its brands, Facebook, and anyone involved in the production, development or execution of this Contest and their respective parent companies, owners, subsidiaries and affiliates; and each of their respective officers, directors, representatives, attorneys, successors and assigns (collectively, the "Indemnified Parties") shall not be liable for any and all actions, claims, including any third party claims, injury, liability, losses, expense or damage arising in any manner, directly or indirectly, arising from or relating to this Contest, including entry and participation in this Contest, or the acceptance, possession, use or misuse of any prize or the use or misuse of any submitted comments. Sponsor may prohibit you from participating in the Contest or winning a prize if, in its sole discretion, it determines you are attempting to undermine the legitimate operation of the Contest by cheating, hacking, deception, or any other unfair playing practices of intending to annoy, abuse, threaten or harass any other participants or Sponsor representatives. 8. **DISPUTE RESOLUTION/GOVERNING LAW.** To the fullest extent permitted by law, by participating in the Contest, you agree that: (a) any disputes, claims or causes of action arising out of or relating to these Official Rules or this Contest shall be filed exclusively in the federal or state courts in the City of New York, County of New York and you hereby consent and submit to the personal and exclusive jurisdiction of such courts for the purposes of litigating any such action, waiving any right of change of venue; (b) any such dispute, claim or cause of action shall be resolved individually, NOT as part of a class action; (c) any claims/judgments/awards shall be limited to actual out-of-pocket costs incurred, but NOT attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, (i) punitive, special, indirect, incidental and consequential damages, (ii) any other damages, other than for actual out-of-pocket expenses, and (iii) any and all rights to have
